TAP Overview

- Funding source for non-motorized transportation infrastructure projects
- Municipalities are responsible for >20% of project costs, are reimbursed for remaining <80%
- Examples in our region: Littleton River District & Colebrook Main



Project Prioritization Process

- Regional project rankings submitted by RPC's
 - NCC staff develop draft rankings
 - TAC reviews and finalizes
 - Regional rankings count for 6% of overall project score
- Final project rankings performed by Statewide TAP Advisory Committee
- Number of funded projects varies depending on size of projects submitted and available funding

Albany: Passaconaway Road Reconstruction, Realignment, and Safety Improvements


- Purpose & Need:
 - Roadway as narrow as 16 feet
 - Steep bank to Swift River with little protection
 - Embankment erosion contributes to drainage issues and road damage (poor condition)
 - Road is used by bicyclists (NCC counts)





Albany: Passaconaway Road Reconstruction, Realignment, and Safety Improvements

- Total project cost: \$503,681.88 → TAP request: \$402,945.50 (80%)
- Widening and realignment of "Narrows" section of road
- Reconstruct/repave 6,325' of road surface
- Installation of guardrail on river side of rd
- Slope stabilization





Albany: Passaconaway Road Reconstruction, Realignment, and Safety Improvements

• Project Notes:

- Have already appropriated some funds into Capital Reserve Fund
- Selectboard committed to 2019 warrant article for funding
- Letters of support from selectboard, Rep. McKonkey, Councilor Kenney, WMNF, MWVEC
- Road widening, surface improvements, guardrail provide increased safety for bicyclists
- Does not provide dedicated facility for bicyclists or pedestrians
- Primarily a recreational bicycle route/access, though used by some local residents




Berlin: Hutchins St Sidewalk Extension

- Purpose & Need:
 - No sidewalk present in project area
 - Road experiences heavy truck traffic
 - No connection from Napert Village area to larger residential neighborhood, Mason St bridge/downtown
 - Completing pedestrian loop connecting 12th St bridge



Berlin: Hutchins St Sidewalk Extension

- Total project cost: \$715,240 → TAP request: \$572,192 (80%)
- Construction of 1,760 feet of sidewalk
- Pave driveway crossings





Berlin: *Hutchins St Sidewalk Extension*

Project Notes:

- Have already appropriated all necessary funds from City's General Fund
- Letters of support from city council and planning board
- Project identified by local youth in presentations to planning board and city council
- Project connects isolated residential area to larger neighborhood, parks, and downtown, and completes pedestrian loop that is part of multi-decade East Side Arterial project
- Pedestrian connectivity to residential areas identified as goal in Master Plan
- Potential ROW ownership issues, though unlikely




Conway: *MWV Recreation Path – Phase 2*

- Purpose & Need:
 - Connect Phase 1 Rec Path project (CMAQ-funded) from Hemlock Lane to existing Rec Path starting Smith-Eastman Park on Meetinghouse Hill Road
 - Provide alternative bikeped route to US 302 in Redstone area



Mount Washington Valley Recreation Path




Conway: *MWV Recreation Path – Phase 2*

- Total project cost: \$1,291,660 → TAP request: \$800,000 (68%)
- Construction of paved, 1.75-mile, 10-foot wide multi-use path

Conway: Section of Conway Recreation Path – Phase 2

• Project Notes:

- Part of a phased plan (codified in Town Master Plan and Town Trailways Plan) for a network multi-use paths
- Public hearings for project held in front of Selectboard and Conservation Commission
- Rural area of town, but does connect existing and planned paths
- Town needs to raise ~\$500k for match; previously raised funds for Phase 1.
 Selectboard has committed to placing warrant article.
- Application indicates support from a variety of community partners



Franconia: NH 116 Multi-Use Path and Road Widening


- Purpose & Need:
 - Provide safer walking and cycling along curvy, narrow section of NH 116
 - Connect residential area (Bickford Hill Rd) to Town Center/existing paths





Franconia NH 116 Multi-Use Path and Road Widening

- Total project cost: \$896,400 → TAP request: \$224,100 (75%)
- Construction of paved, 8foot wide multi-use path
- 3-foot roadway widening to allow striping of bike lane





Franconia: NH 116 Multi-Use Path and Road Widening


• Project Notes:

- Need for project identified in 2008 Town Master Plan
- Selectboard has committed to placing warrant article to fund match
- Connects residential area to town center
- Outer limits of project area are fairly rural
- Letters of support from Planning Board, Conservation Commission, Lafayette Recreation Association, Lafayette School PTO, Friends of Profile Trails, NH State Rep. Skylar Boutin, and Ammonoosuc Regional Energy Team



Northumberland: Groveton Village Safe Routes to School Walkway Project


- Purpose & Need:
 - Safety concerns with cracked, heaved, crumbled and salt-damaged sidewalks in Village center
 - Areas of Village center without sidewalks (Elementary School)





Northumberland: Groveton Village Safe Routes to School Walkway Project

- Total project cost: \$1,000,000 → TAP request: \$800,000 (80%)
- Rehabilitate and/or reconstruct 6,300 linear feet of sidewalk
- Construct new sidewalk near Elementary School on Church St





Northumberland: Groveton Village Safe Routes to School Walkway Project

• Project Notes:


- Sidewalk improvements identified in 2013 Safe Routes to School Travel Plan that was endorsed by Town, School, & Police, and is incorporated into 2014 Town Master Plan
- Selectboard has committed to placing warrant article to fund match. Town has \$200,000 previously raised for different project that can be reallocated.
- New sidewalk construction on Church St next to Elementary School may require conversion of road to one-way due to smaller ROW, will need to approved via warrant article.
- Letters of support from Congresswoman Kuster, District 2 State Rep. Moynihan, District 7 State Rep. Merner, Regional Economic Action Team (GREAT), SAU 58, Groveton Ambulance Corps, and the Northumberland Police Department



Whitefield: King's Square Sidewalk Replacement, NH 116 Sidewalk Construction


- Purpose & Need:
 - Uneven and cracked sidewalks in King's Square
 - Lack of pedestrian access from King's Square to senior living facility, town hall, and Weeks Medical Center on NH 116





Whitefield: King's Square Sidewalk Replacement, NH 116 Sidewalk Construction

- Total project cost: \$431,200 → TAP request: \$344,960 (80%)
- Replace sidewalks on Elm St and Lancaster Rd (US 3)
- Construct new sidewalk along NH 116 to Weeks Med. Center



Whitefield: King's Square Sidewalk Replacement, NH 116 Sidewalk Construction

- Project Notes:
 - Community support for sidewalk improvements identified in recent community survey. Voters have approved locally-funded sidewalk projects in recent years.
 - Selectboard has committed to placing warrant article to fund match.
 - Project improves pedestrian connectivity to and within town center
 - Significant grade issues along NH 116; warrant article will ask for additional funds for potential costs
 - Letters of support from Weeks Medical Center, Summit by Morrison Senior Living
