



History...

"A well-defined regional planning program will supply the various communities with the help they require in planning for the present and future needs of New Hampshire residents, aiding in the growth, development, and prosperity expected for the years ahead."

Report of Governor John W. King's Committee on Regional Planning, March 1969.

Why...

The Governor's Committee on Regional Planning identified the following needs:

- Ensure that municipalities were coordinated in the access to and delivery of federal grant programs.
- Facilitate the development of regional relationships for the delivery of certain community services.
- Conduct comprehensive regional planning to support community planning.



How...

At the time The Resources Development Center of UNH completed a study to determine boundaries that considered:

- Regional groupings in use at the time by State Government
- Shared functions between municipalities
- The potential for urban activity in municipalities
- The location of existing or potential regionally-significant growth centers




17 regions were identified

- Regions 1-5: North Country Council
- Regions 6-7: Lakes
- Regions 8-9: Upper Valley Lake Sunapee
- Regions 10-11: Southwest
- Region 12: Central
- Region 13: Southern
- Region 14: Nashua
- Regions 15-16: Rockingham
- Region 17: Strafford

WHAT...

- 1969 RSA 36:45-58 (revised statues annotated)
- Enabled municipalities to form Regional Planning Commissions
- Most being formed in the 1970's

- 9 Regional Planning
 Commissions
- North County Council formed 1973
- 50 communities and 25 unincorporated places



RSA 36:46-58

- Voluntary association of towns, cities and counties.
- Provides a outlet for planning resources, services and assistance to benefit the region.
- Foster "coordinated plan for development of the region"


- North Country Council has 41 member communities.
- Provides technical assistance to communities in areas in order to promote the well-being of the environment and those who live here.
- Regional planning focused on land use, transportation and natural resources.

Formation

- Regions are delineated by Office of Strategic Initiatives.
- Any municipality or county may become a member.
- Each member may have 2 commissioners communities with population over 10,000 and under 25,000 may have 3.
- Member residents are nominated by the Planning Board to be appointed by the municipal officers.
- 4 year term
- Commissioners act as an agent for both the Commission and related member municipality.

Powers and Duties

- Powers are advisory and do not hinder powers of individual municipalities.
- Prepare comprehensive regional master plan and housing needs assessment - updated every five years.

Economic Development


- Economic Development District (EDD)
