The Mobility Manager will enhance transportation access for vulnerable populations, foster multi-agency partnerships, and ensure efficient, customer-centered mobility solutions that address community needs.

#### **Role Overview**

The Mobility Manager supports the Regional Coordinating Council (RCC) and the Lead Agency (Tri County Community Action Program) in developing and implementing a customer-centered approach to transportation access and social services for vulnerable populations. This role involves fostering multi-agency partnerships to enhance transportation efficiency and effectiveness. The Mobility Manager will engage with state, regional, and local officials and community leaders to advocate for coordinated services. Additionally, they will collaborate with the State Coordinating Council (SCC), other Regional Mobility Managers, and the State Mobility Manager on strategic planning efforts, including human services coordinated plans.

## **Key Responsibilities**

- Develop projects in coordination with the Lead Agency and RCC members to expand access to transportation and social services.
- Cultivate multi-agency partnerships to improve transportation services for vulnerable populations.

- Conduct outreach to area employers and employment agencies to promote transit programs for employees.
- Plan and coordinate special events and promotional activities related to public transportation and service coordination.
- Assist in designing nontraditional operational functions to enhance service delivery.
- Build supportive community networks.
- Research grant opportunities and assist the Lead Agency in compiling and submitting grant applications.
- Develop special projects within the region, such as recruiting volunteer drivers and improving the cost-efficiency of transportation services.
